NOT A VALID DOCUMENT



1. Obtaining a Certificate for the Land Registry Office (Tabu)

In accordance with the provisions of Section 324 of the Municipalities Ordinance, the municipality will issue a certificate confirming that all debts owed to it by the property owner (for that property only) have been paid in full.

For this purpose, all debts must be settled, including arnona debts, levies, betterment levy and/or any other mandatory payment due to the municipality in respect of the property.

The certificate will be issued only after the payment has actually been settled, and will be valid until the end of the periodic bill period.

Obtaining the certificate is subject to payment of a fee.

The following details and documents are required in order to obtain the above certificate:

- A copy of a signed sale contract and/or signed divorce agreement and/or inheritance order and/or probate order and/or transfer affidavits signed by both parties and by an attorney.
- An up-to-date Land Registry (Tabu) extract.
- A copy of an ID card + appendix and/or a copy of a passport and/or a copy of a registration certificate from the Registrar of Companies.
- For some properties (private houses, roof and garden apartments, and properties not used for residence), after all the documents are received, the property is inspected by the Engineering Administration — an inspection that includes an inspector's visit and measurement of the property by a certified surveyor.

2. Filing an Objection and Appeal Regarding the General Arnona — Rights and Deadlines

An objection may be filed with the Arnona Administrator against the payment notice within 90 days of its receipt, and an appeal may be filed with an Appeals Committee, on the basis of one of the following grounds:

- The property is not located in the zone specified in the notice.
- An error was made in stating the property type, its size or its period of use.
- You are not the holder of the property within the meaning of the Municipalities Ordinance

The objection may be sent to the Arnona Administrator by mail to the Sample City Municipality, P.O.E. 100, Sample City 0000000, or via an online inquiry through the municipal website.

The Arnona Administrator will reply in writing within 60 days of receipt of the objection.

Anyone who considers themselves aggrieved may appeal the reply to the objection to the Appeals Committee within 30 days.

Filing an objection is not grounds for delaying or deferring the payment.

3. General Residential Discounts

The Sample City Council has approved the granting of arnona discounts as detailed in the Sample City Arnona Order.

Those entitled to a discount on arnona taxes as prescribed by any law and/or under the Sample City Arnona Order will enjoy one discount only, the higher of them.

The discount will be granted for one residential dwelling only, actually held by the person entitled to the discount.

4. Notice of Change of Holders

The municipality must be notified immediately and in writing of any change in the ownership and/or holding of the property, attaching:

- A signed contract (sale, rental). For a rental — a contract for a period of at least one year and not less.
- A copy of an ID card + appendix and/or a copy of a passport and/or a copy of a certificate of registration with the Registrar of Companies

Please note: until the notice is delivered, the payment obligation applies to the holder registered with the municipality.
